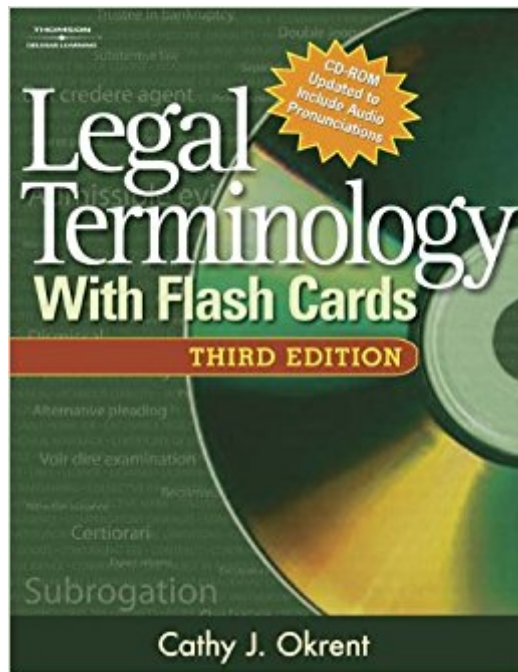

While a great book with lots of questions and practice, this book should be sold with a major emphasis that it is STUDENT only. There is no way for a student to check their answers. I got this book for study outside my coursework and am getting a lot out of it -- but it is very frustrating to be unable to check my work. Only Instructors are allowed to purchase the keys to the text. BE AWARE of this, Students! (BTW: The case studies at the start of each section are very condensed and do not really engage the student to connect it to the remainder of the practice section.)
