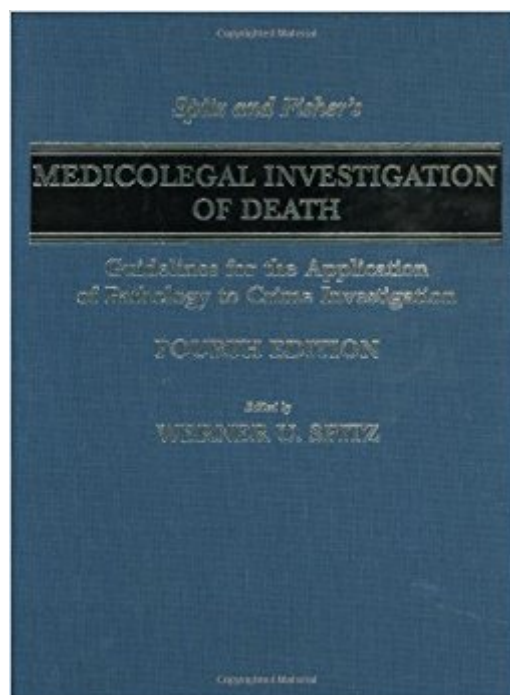

I am a 37 year veteran of law enforcement and have been involved in everything from basic patrol, investigations, supervision and executive administration. Dr. Spitz's text is an incredible resource for
